If the minor child or I fail to show up to the martial arts meet, for any reason, I knowingly forfeit this seminar and all applicable fees. I have read the agreement and fully understand its terms, understand that I or the minor child have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid that the balance, notwithstanding, shall continue in full force and affect.
